**FARMERS' MARKET**  
**Farmers' Market Guidelines**

**Participation:**

1. The Dixie Farmers' Market consists of Kentucky growers of vegetables, fruits, transplants, and other related agricultural and horticultural products; Kentucky producers of value-added items such as baked goods, pickles, preserves, etc.
2. All producers/Vendors must complete a membership application available at the City of Erlanger, 505 Commonwealth Avenue, Erlanger, KY 41018, on-line at [www.ci.erlanger.ky.us](http://www.ci.erlanger.ky.us), or contact Missy Andress at 859-727-2525 to have an application sent, e-mailed, or faxed to you.
3. It is recognized that although members sell as individuals, The Dixie Farmers' is a cohesive unit and its success depends on the cooperation and joint effort of all Producers/Vendors as a whole.
4. Producers/Vendors must make, grow, and harvest all the products that they sell at the Dixie Farmers' Market.
5. Members are expected to abide by The Dixie Farmers' Market guidelines.
6. The Market reserves the right to prohibit anyone from selling at The Dixie Farmers' Market if guidelines are not met.

**Acceptable Products:**

1. The Dixie Farmers' Market will provide an outlet for the sale of fresh picked produce, related agricultural, horticultural products and value added products that have been grown and produced by the Producers/Vendors.
2. The Dixie Farmers' Market shall have the right to prohibit the sale of any unacceptable item.

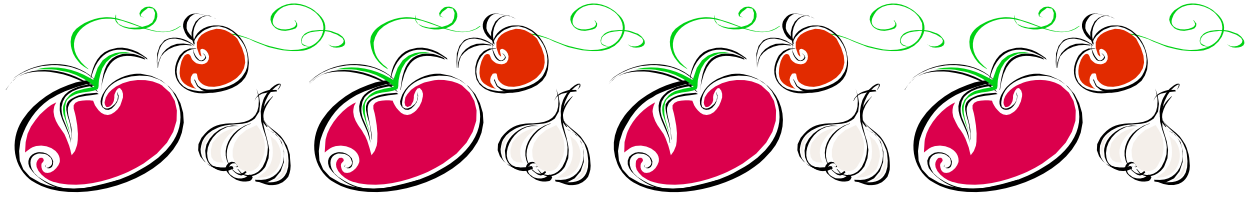
**Market Site:**

1. The Dixie Farmers' Market will be located at the Erlanger Baptist Church at 116 Commonwealth Avenue, Erlanger, KY 41018.
2. The market will operate on Thursday afternoons from 3:30 p.m. to 6:30 p.m., from late-April through Mid-October.

**Market Operation:**

1. Fresh produce must be displayed at least 12 inches off the ground.
2. Producers/Vendors must post their farm name at their stall each market day.
3. The "Kentucky Proud" logo should be displayed on produce.
4. Prices should be clearly displayed.





**Appearances and Conduct:**

1. Producers/Vendors will be neat, suitably dressed, and deal with the public in courteous and appropriate manners.
2. All members will display their products neatly and attractively with consideration for the other members and shoppers.
3. Members are responsible for their own stalls, will supply all necessary trash containers, and will leave their site clean and in a condition acceptable to The Dixie Farmers' Market manager and also the property owner.
4. Vehicles must be clean—free from dirt, manure, etc.

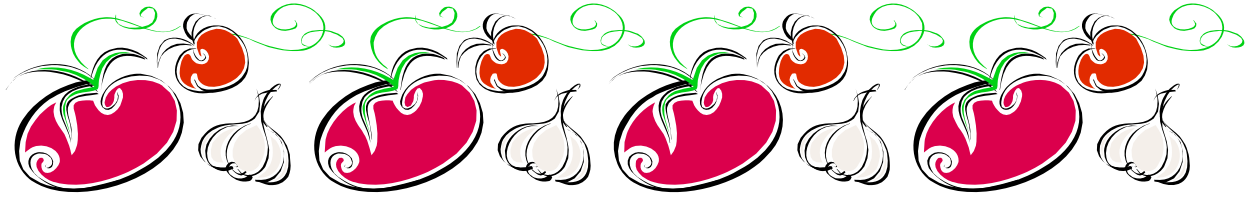
**Market Fees:**

1. Producers/Vendors—One year Dixie Farmers' Market membership fee is \$50.00 and entitles the member to sell at The Dixie Farmers' Market.
2. All money raised from the Market fees will be used for market operations and promotions.
3. All fees are non-refundable.
